## 1.0 Objective

The objective of this work is for a subcontractor to provide web hosting and on-demand collaborative development of internet content for Hanford Tank Waste Operations & Closure, LLC (H2C).

This work is to provide administrative functions or program support services where the products to be generated by the services are subject to control by established industry standards, State or Federal rules and regulations.

## 2.0 Background/Introduction

As a prime contractor to the U.S. Department of Energy, H2C is in the process of preparing a safe and effective system/process for retrieval and movement of tank waste feed materials to the waste treatment plants. H2C is also responsible for deploying and implementing several technologies to safely, efficiently, and effectively retrieve Single Shell Tank waste for transfer to the safer Double-Shell Tanks.

H2C External Affairs works to align H2C's mission strategies and promote H2C through messaging and programming that support the overall goals of the H2C prime contract with the U.S. Department of Energy. H2C External Affairs requires a website that is suitable to support this H2C-led strategy.

This work provides administrative or program support functions only. No hands-on field work activities will be performed.

#### 3.0 Scope

## 3.1 Web Hosting and Maintenance

Subcontractor shall provide managed hosting services for the H2C External website at: <a href="https://www.hanfordanks.com">www.hanfordanks.com</a> and Hanford vapors resources website <a href="https://www.hanfordvapors.com">www.hanfordvapors.com</a>.

Subcontractor shall provide website maintenance support for the H2C External web site at: <a href="http://www.hanfordtanks.com">http://www.hanfordtanks.com</a> and vapors resource website at www.hanfordvapors.com.

The WRPS website is built on ExpressionEngine content management framework, utilizes PHP 5.3.27, utilizes a MySQL database backend (version 5.1.66) and lives on a

Linux 3<sup>rd</sup> party webhost.

Subcontractor shall provide H2C access to internet-based subscription services as requested, including examples such as flippingbook.com and monsterinsights.com, to enable the analysis of metrics related to web-based communication efforts.

## 3.2 Technical Support/Ad-Hoc Services

On an as-needed basis the Subcontractor may be required to provide technical support/ad-hoc services. These services may include content manager change, website redesign and/or enhancements to existing website. Services may include providing video graphics, content management tools, website cleanup, navigation management, link fixes to provide information delivery of specific data, document/media conversions, maintenance of graphics, data transition and static HTML pages, and registration and management functions to the H2C domains.

The Subcontractor may create user manual and conduct training.

Technical support services provided by the Subcontractor beyond the managed hosting services and website maintenance will be provided on an as-needed basis with prior arrangements made with H2C. For all technical support, website enhancements or ad-hoc maintenance work, the Buyer's Technical Representative or designate must approve all activities/deliverables prior to the initiation of work. Specific deliverables will be identified and agreed to by the Subcontractor and H2C at the time of commencement of work.

Technical points of contact will be a representative from the External Affairs and/or the Information Resource Management organizations.

#### 4.0 Submittals

No submittals are expected as part of this scope.

#### 5.0 Acceptance Criteria

Work products and services provided must meet established applicable TOC procedures for control and review of work products. Acceptance shall be based on validation by H2C that Subcontractor has resolved and incorporated all H2C comments. Subcontractor personnel providing support under this subcontract shall possess the qualifications, certifications and any other attributes required to complete assigned work.

## 6.0 Configuration Management and Standards

#### 6.1 Configuration Management Requirements
