1. Background and Current Operation

The [Out\(sider\) Preservation Initiative \(OPI\)](#), housed at the University of Virginia’s Center for Cultural Landscapes (CCL), is a research project that reimagines preservation by focusing on the origin stories of Black settlements and towns and the descendants of the founders. Directed by Dr. Andrea Roberts, the initiative centers the knowledge, experiences, and visions of Black descendant communities that have been historically excluded from formal preservation practices.

Building on Dr. Roberts’ foundational work with [The Texas Freedom Colonies Project™](#), the initiative seeks to expand the digital presence of descendant communities nationally to support contemporary descendant communities in documenting, preserving, and planning for their places on their own terms. The initiative prioritizes cooperative practice, technical innovation and interdisciplinary approaches that bridge academic research with community-led action.

The initiative has four key components:

1. Provide Grants
2. Create a Portal
3. Develop “Preservation” Pedagogy
4. Produce Events and Communities of Practice

The forthcoming Out(sider) Preservation Initiative web portal will serve as a digital infrastructure for:

- Archiving descendant-led preservation efforts
- Sharing cultural practices
- Mapping diasporic and historical connections
- Providing training tools and resources for communities
- Modeling reflective, ethical engagement and digital stewardship

2. Purpose of the Request for Information

This RFI is intended to:

- Identify qualified developers with experience in community-based digital projects
- Gather insights into technical feasibility and implementation strategies
- Build a shortlist of vendors who will be invited to submit bids.
- To showcase shortlist of vendors at an in-person Out(sider) Preservation Initiative Symposium in Charlottesville, VA, scheduled for February 2026.

This process is part of a collaborative, trust-building approach that prioritizes relationship development and mutual learning as much as technical innovation. We seek firms that embrace iterative development, co-creation, and ethical data stewardship rooted in Black descendant-led cultural preservation.

- b. What makes your team a strong fit for a community-led initiative like the Out(sider) Preservation Initiative?

4. Functional Features and Needs

- **Community Archives & Collections:** Host and preserve media, documents, and metadata.
- **Interactive Mapping & Spatial Narratives:** Center dynamic mapping to visualize historical and contemporary place-based connections.
- **Timelines & Digital Storytelling Tools:** Integrate galleries, timelines, and story maps.
- **Search & Discoverability:** Ensure accessible UI/UX and strong SEO.
- **Public & Private Entrances:** Support differentiated access levels (e.g., public-facing, descendant-only).
- **Multilingual & Accessible Design:** Meet ADA compliance, support multilingual interfaces, and use universal design principles.

- **CMS/Platform Recommendations:** Preference for open-source, scalable, sustainable systems, and minimal computing for web browsers. Optional ability to create a phone app as well.
- **Future-Proofing:** Enable long-term data backups, migration, and preservation.
- **Data Sustainability Plan:** Include strategies for digital longevity, redundancy, and content stewardship.
- **Templates for Grantees and Pilot Project:** Photo, video, bio, place biography, leader biography, context/ description of content, spatial tagging, and metatagging.
- **Discussion Forum:** Create a secure, moderated space for users, project leaders, and partners to connect, share updates, and engage in dialogue across projects and regions.
