

# Southeast Colorado Regional Housing Authority Request for Qualifications/Proposals

Proposals Due: November 21, 2025, by 12 p.m.

## Introduction

The Southeast Colorado Regional Housing Authority (SECRHA) is soliciting Request for Qualifications (RFQ) for website design services for the design of a new website, hosted under <a href="www.seced.net">www.seced.net</a>, to engage the community members of our region with our next phase of affordable single-family home construction over the next two years. The website will serve as the project phase home for all interested parties and will host all information including: house plans and elevation views, an interactive site map, homebuyer inquiry process and forms, homebuyer application process and forms, and community feedback platforms.

The goal of the RFQ scope of services is to ensure the selected firm completes all necessary website design work to allow the SECRHA to begin the project community engagement process by December 16, 2025.

## **RFQ Requirements**

The format of this submittal is a formal PDF document.

## 1. Cover Letter (not to exceed two pages)

- a. Background of your firm/project team and experience with design and development processes.
- b. Your experience working with similar communities and your familiarity with Southeast Colorado.
- c. Please provide specific and recent examples of lessons learned in similar communities and the solutions you have implemented going forward.
- d. The reasons why the SECRHA should select your firm/project team.

# 2. Scope of Design Services

The selected firm will be required to develop a fully-functional website to be hosted under <a href="www.seced.net">www.seced.net</a>. The website will serve as the project phase home for all interested parties and will host all information including: house plans and elevation views, an interactive site map, homebuyer inquiry process and forms, homebuyer application process and forms, and community feedback platforms. Home design plans and other content will be provided. The design firm will work side-by-side with the SECRHA and the architectural firm under contract with the SECRHA to fully develop the website. Google Forms are preferred. Design in such a way that the website can be updated and maintained internally at SECED/SECRHA.

#### 3. Presentation

The selected firm will be asked to present the website to the SECRHA Board of Directors on Tuesday, December 16, 2025, at 1pm. Virtual presentation is possible.

## **Submission Requirements**

The SECRHA is open to consideration of all creative and viable website design services that are consistent with the objectives of this Request for Qualifications (RFQ). Interested parties should review the contents and requirements of this RFQ and submit their responses no later than 12:00 p.m. on November 21, 2025.

- 3. Successful history and experience with past projects in Southeast Colorado;
- 4. Overall strength of project proposal;
- 5. Proposed Project Schedule;
- 6. Proposed Budget;
- 7. References.
